TERMS AND CONDITIONS

1. General Requirements

There is no age limit for course participants.

2. Participation / Enrollment confirmation

- 2.1. After enrolling in the course, the participant is sent confirmation (referred to below as "enrollment confirmation") by TAUNUS LINGUA ("TL") of enrollment in the selected course. With receipt of the enrollment confirmation by the participant, the contract takes effect.
- 2.2. An invoice is forwarded with the enrollment confirmation, informing the participant of the payable course fees, which include all services, indicating the payment deadline and the participant number.
- 2.3. In principle, consumers have a right to cancel. More information on the right to cancel is provided in the notice on the right to cancel at the end of the Terms and Conditions.

3. Prices and terms of payment

- 3.1. The course fee is payable in full to the TL at the payment deadline shown in the invoice. The payment date is defined as the date at which the payment is credited to the TL account specified in the enrollment confirmation.
- 32. All bank charges related to the payment of the course fee shall be borne by the course participant.
- 3.3. If the TL does not receive full payment of the course fees by the due date, the participant will no longer be entitled to the services booked. In this case the TL is entitled to make the services available to other interested parties.
- 3.4. In case of non-attendance at the booked course, delayed arrival, early departure or withdrawal from a course, or any other absences (e.g. due to illness), there is no claim to reimbursement of the course fees.
- 3.5 If you enroll a week later than the term starts, we charge 95%, 2 weeks later we charge 90%, 3 weeks later we charge 80%, 4 weeks later we charge 70%, 5 weeks later we charge 60%, 6 weeks later we charge 50% of the total course fee in case of a 10 week course.

4. Changes to course bookings

In exceptional cases participants may change the services booked (e.g. the course date) in consultation with the TL. The first change is free of charge. A fee of €60 is payable for each additional booking change.

5. Cancellation

- 5.1. The course participant can cancel the course booking subject to the following conditions.
 - $_\ensuremath{\mathsf{In}}$ case of cancellation no later than four weeks prior to the start of the
 - course, the TL will withhold an administrative fee of €50. _In case of cancellation no later than one week prior to the start of the
- course, TL will withhold an amount equal to 25% of the course fee,
 - but not less than the administrative fee of \in 50.
 - In case of cancellation no later than one day prior to the start of the course, TL will withhold an amount equal to 50% of the course fee.. In case of withdrawal after the start of the course, TL will withhold 100% of
 - the course fee.

The course participant may submit evidence to show that it would be appropriate for a lesser amount to be withheld in an individual case.

5.2. The cancellation must be submitted in writing (or by e-mail) to TL using the contact addresses indicated in the enrollment confirmation. The cancellation date is defined as the date of receipt of the cancellation declaration at the contact address specified in the enrollment confirmation.

6. Course level assignment / class size

- 6.1. The assignment to a course level is made on the basis of a placement test carried out at the course location.
- 6.2. In all courses, the maximum class size is 10.

7. Responsibilities of participants

- 7.1. It is the responsibility of the course participant to ensure at his/her own expense that his/her stay in Germany is in compliance with the law and that he/ she is in possession of any required entry permit, residence permit or visa.
- 7.2. It is the sole responsibility of the course participant to take out health insurance and accident, liability and personal property insurance. TL assumes no liability in this area.
- 7.3. Participants are obliged to comply with the course rules applicable to TAUNUS LINGUA

8 Liability of the TL

- TL is subject to liability regardless of the legal cause only in case of gross negligence or intent.
- 8.2. TL is also liable in case of ordinary negligence in case of damage resulting in death, injury or harm to health as well as damages for the culpable violation of a material contractual violation.
- 8.3. Any other contractual or tort claims of the course participant are explicitly precluded.

9. Force majeure

Neither TL nor its employees are liable for non-performance of contractual obligations or damages to the extent that they are caused by force majeure, in particular re, water, storm or other natural events, explosion, strike, war, civil unrest or other reasons outside the sphere of responsibility/in uence of the TAUNUS LINGUA.

10. Privacy protection

TL collects, processes and uses the personal data of the course participant both for the purpose of fulfilling the contract signed with the course participant and as permitted by law and under the terms of any signed declaration of consent in compliance with privacy protection laws. For further details see the separate privacy declaration to which we hereby explicitly refer.

11. Applicable law

These terms and conditions and all legal relations between the TL and the course participant are subject to the laws of the Federal Republic of Germany. The place of jurisdiction is Frankfurt, Germany.

12. Severance clause

Should sections or individual formulations in these terms and conditions prove invalid or ineffective, this shall have no effect on the remaining sections and their validity. The ineffective provision shall be replaced by the legally admissible provision that most closely approximates the content and economic effect of the ineffective provision.

Notice of right to cancel and cancellation form

Consumers have a right to cancel in accordance with the following conditions. For this purpose, a consumer is defined as any natural person entering into a transaction for purposes not primarily related to commercial or self-employed activities:

1. Notice of right to cancel

A right of revocation exists only if the binding registration for a language course took place during an event outside of our business and classrooms or as a distance contract (by telephone, Internet, WhatsApp, SMS). In this case, you have the right to withdraw from this contract within fourteen days of the date of conclusion of the contract, without stating a reason. In the case of a binding registration within14 days before the start of the booked language course for a language course, the cancellation period ends on the day before the beginning of the course.

There is no right of revocation if

- a. the registration or the lesson contract took place on your initiative in the rooms of our language school or was completed,
- b. the registration took place after sending the terms and conditions by e-mail to you and consequently there was already e-mail correspondence between you and the institute about the modalities of the course and the payment of the course fee. Likewise, there is no right of withdrawal for the corresponding course after the beginning of the course.
- c. in case of individual lessons you gave your express consent in form of an individual appointment for the individual lessons and the teacher therefore began to provide services (eg in form of lesson preparation, etc.).

In order to exercise your right of withdrawal, you must inform the Institute by means of a clear statement (eg a letter or e-mail sent by post) of your decision to withdraw from this contract:
